Off 2 Preschool Must be 2 by first day of class.

Off 2 Preschool is a great way to introduce your child to a preschool setting. This class is for the toddler who is ready to start exploring on their own. One of the most important aspects of early development is becoming comfortable with separation, encouraging independence and fostering communication skills. Classes will follow a weekly theme and include circle time with songs, a story, snack time, socialization and playtime. Fine and gross motor skills will be enhanced through games and crafts. Parents/caregivers are asked to be available until children build trust with their new teachers. Children must be potty trained, or a parent/caregiver must be available for bathroom assistance. Class will meet Wednesday mornings for one hour and fifteen minutes. (Min/Max: 4/6) Location: LP - Kindergarten K.E.E.P. Building

Four's Classroom

Must be 4 years old by October 30, 2018 or by Preschool Supervisor's approval

Your little one is getting smarter by the day! The Park District is keenly aware this year is full of crucial cognitive milestones that are preparing them for kindergarten. They are starting to get the hang of numbers, patterns and time and even figuring out colors. They are expanding critical thinking skills, such as identifying, classifying, comparing, contrasting, sequencing, predicting and problem solving. Advances in hand-eye coordination help four-year-olds do puzzles and play with toys that have small parts. This program includes readiness in reading (Jolly Phonics Program), literature, writing, science, technology, social science, art and music. It's a critical development year and we ensure they make observable progress in all areas. **The Preschool follows the District 220 calendar, Sept. 5 - May 15. Pre-K Classroom

This class is perfect for children who miss the September 1 age requirement for kindergarten and/or who will be attending Kindergarten in the 2019 - 2020 school year and are ready for a four or five day program. The Pre-K curriculum has been developed to meet the specific skills needed to prepare a child for kindergarten. This program includes readiness in reading (the Jolly Phonics program is used), literature, writing, math, science, social science, art, music, gross and fine motor skills, and social/emotional readiness. One of our main goals is to foster children's creativity, originality, and imagination. The classroom is a playful and creative environment where children can use their literacy, cognitive and mathematical skills throughout their daily activities. The Preschool follows the District 220 calendar, Sept. 4 - May 16. Classes start the Wednesday FOLLOWING Labor Day. (Max: 20)

Drop -In Lunch Bunch Program (Sept. - May) End of Class - 12:30pm

Lunch Bunch offers an extra hour for lunch and socialization to children enrolled in the Preschool. The Preschool is a peanut and tree nut-free zone, and children are required to bring their own lunch. (Min/Max: 4/20). Instructor: Preschool Staff.

Fee: \$10.00 per day for 3's/4's classroom. \$5.00 per day for Pre-K classroom.

Drop-In Extended Day (Sept. - May) End of Class - 2:00p

Extend the preschool day! Includes Lunch Bunch. Enjoy extra time with friends and benefit from the additional amenities the Park District has to offer. Min/Max: 4/20). Instructor: Preschool Staff. Fee: \$20 per day for 3's/4's classroom.

\$16 per day for Pre-K classroom.

Extended Day Program (Sept. - May)

Open to all preschool and kindergarten students in the community! AGES: 3 TO 6 YEAR OLDS

The extended preschool day begins with Lunch Bunch at the preschool (children are required to bring their own lunch; our preschool is a peanut and tree nut-free zone). After Lunch Bunch, children in the program will enjoy structured playtime, enrichment activities and gross motor skill time with their friends. This program follows the Barrington Park District Preschool calendar. This program can be a drop-in, daily or monthly option. Daily options are listed above. For monthly discounted options, see fees listed under classroom descriptions. (Min/Max: 6/16)

Fee: \$20 per day for 3's/4's classroom. See below for discounted monthly fee. \$16 per day for Pre-K classroom.
