Waiver and Release of All Claims 2019

IMPORTANT INFORMATION

The Barrington Park District, BMS PTO & St Anne's Home and School are committed to conducting their recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Parties continually strive to reduce such risks and insist that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for the 2018 BMS Ski Club must recognize that there is an inherent risk of injury.

You are solely responsible for determining if you or your minor child/ward is physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

WARNING OF RISK

Skiing and snowboarding are sports intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including but not limited to head injury, brain damage, spinal cord injury, paralysis, and bone and joint injuries. All hazards and dangers cannot be foreseen. The very nature of skiing and snowboarding is hazardous and risky, including but not limited to inexperience, losing control, snow blindness, overexertion, horseplay, carelessness, falling, collisions with other skiers/boarders and with stationary objects, lack of skill or technique, attempting a run beyond one's abilities, poor or defective equipment, acts of God, inclement weather, icy and dangerous conditions, failure in supervision or instruction, and all other circumstances inherent to the sports of skiing and snowboarding. These risks are particularly enhanced during nighttime skiing/snowboarding where lighting conditions are different and participants may become tired due to both lack of sleep and physical exertion. In this regard, it is impossible for the Parties to guarantee absolute safety.

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this form carefully and be aware that in registering for and participating in the BMS Ski Club, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this trip (including injuries and damages sustained during transportation to and from the ski facility).

In consideration of your accepting my child's entry, I recognize and acknowledge that there are certain risks of physical injury to participants in this trip, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I hereby, for myself, my child, my heirs, executors and administrators, agree to waive and relinquish all claims my minor child/ward or I may have (or accrue to me or my child/ward) as a result of participating in the BMS Ski Club against the Barrington Park District, School District 220, or St. Anne's Parish School, and their respective officials, agents, volunteers and employees.

BMS SKI CLUB CODE OF CONDUCT & CONSEQUENCES FOR VIOLATION 2018-2019

BMS Ski Club requires that the following Code of Conduct shall apply to ALL PARTICIPANTS in the program. This includes students, parents, chaperones, BMS volunteers, BMS Committee Members and Barrington Park District staff. BMS Ski Club shall in all instances related thereunto be guided by the core values of SAFETY, INTEGRITY, RESPECT, GOOD SPORTSMANSHIP and RESPONSIBILITY.

STUDENTS:

Violations for students shall include but are not limited to:

- Profanity or inappropriate language or gestures
- Arguing or showing disrespect to chaperones, volunteers, other students or BPD staff
- Taunting, harassing, bullying or any other degrading activity
- The use of extreme energy drinks (i.e. Monster, Redbull, etc.), alcohol, tobacco or illegal drugs during trips
- Misuse of Barrington Park District or Barrington Middle School (Station/Prairie) facilities/equipment
- Refusal to wear helmet while in ski area

Violation of the above may result in a suspension from one trip (1st offense); and/or expulsion (2nd offense) depending on the severity of the action. See Reference Table 1 – BMS Ski Club Student Code of Conduct and Consequences for Violation available on back of form and on the Barrington Park District’s website.

ADULTS (Parents/Guardians and ALL Adult Family members who have a student in the BMS Ski Club, Volunteers, Chaperones, BMS Ski Club Committee Members and BPD Staff):

Violations for Adults shall include but are not limited to:

- Verbally abusive, attempts to intimidate, is flagrantly rude, or cannot control their language or actions with a volunteer, fellow parent, chaperone, BMS Committee Member or Barrington Park District staff member, will be asked to immediately leave. In addition, his or her \$150.00 chaperone deposit will be cashed.
- Any adult, who commits a second similar offense during the same season, will be banned from participating in the BMS Ski Club and the offending adult’s child(ren) may be barred from participating for the remainder of the Ski Club season.
- Any adult who physically assaults a volunteer, fellow parent, chaperone or Barrington Park District staff member will be banned from BMS Ski Club participation and their child(ren) may be removed from participation in any Barrington Park District programs for one full year from the date of the offense. Upon culmination of the one year suspension, parents may reapply for re-instatement of their child(ren) in the BMS Ski Club. If the adult commits a subsequent offense, he or she and their child(ren) will be permanently banned from participating in BMS Ski Club with no opportunity to appeal.
- Misuse of any of the BMS Ski Club, Barrington Park District or Barrington Middle Schools facilities/equipment will be in violation and will be subject to appropriate consequences.
- Use of tobacco, drugs or alcohol is strictly prohibited while chaperoning. The use of drugs and/or alcohol prior to chaperoning is also strictly prohibited.
- Refusal to wear helmet while in ski area

The BMS Ski Club Committee and the Director of Parks and Recreation may review any Code of Conduct infractions, violations or incidences as outlined above. All suspensions and/or expulsions will be at the sole discretion of the BMS Ski Club Committee. *The term “physical assault” includes, but is not limited to: hitting, striking, slapping, spitting, kicking or contact in any way with any part of the body or the usage of any physical implement as a weapon.

The BMS Ski Club Committee and the Barrington Park District’s Director and Board of Commissioners may review any Code of Conduct infractions, violations or incidences as outlined above. All suspensions and/or expulsions will be at the sole discretion of the BMS Ski Club Committee. BMS Ski Club volunteers who witness infractions may give recommendations for punishment or sanctions for participants who commit a “first offense” violation or infraction of the Code of Conduct. s made by the Ski Club Committee.
