



Dear Friends of the Barrington Park District,

Yesterday afternoon Governor Pritzker issued an Executive Order 2020-10 requiring all Illinoisans to stay home beginning today, March 21, 2020 at 5pm. This order is comprehensive and will impact aspects of our lives. People are only allowed to leave their homes for essential reasons. The Barrington Park District is hoping to reopen facilities and resume programming on Wednesday, April 8, 2020. Please check our website and facebook pages for updated information, as things can change.

**Parks:**

The order specifically states that individuals may leave their residence to engage in outdoor activity such as walking, hiking, running, or biking. **All playgrounds, basketball, tennis and skatepark along with restrooms will be closed as a directive from the Governor.**

**Credits & Refunds:**

Due to the state mandated "Shelter in Place" Order, we have updated our plans regarding credits/refunds.

- **Fitness Memberships:** Members who have paid for an annual membership will have their memberships extended by one month. Members who pay monthly will be charged for the full month of March. Your April bill will not be charged.
- **Rentals & Parties:** As facilities are closed through April 7, 2020 all rentals and parties through April 7 will be rescheduled for a later date.
- **K.E.E.P, Preschool, XStatic Poms and EPIC Cheerleading** monthly EFT'S will be charged when we reopen. Your April bill will be prorated upon reopening.
- **Programs:** Supervisors are reviewing each program effected by the closure to determine if make-up classes can be offered or if program credits will be issued. Supervisors will be sending out updated information within the next couple weeks to communicate these updates.
- **Special Events:** The Easter Egg Hunt, Breakfast with the Bunny and Bunny Home Visits have been cancelled.
