Dear Friends of the Barrington Park District,

Yesterday afternoon Governor Pritzker issued an Executive Order moving the entire state of Illinois to Tier 3 of mitigation in order to help stop the spread of COVID-19. This order begins on Friday, November 20, 2020 at 12:01am until further notice. Tier 3 impacts recreation in several ways. Here are some updates & changes you will find at the park district during this time:

#### **Fitness Center:**

- Masks must be worn at all times (nose & mouth must be covered) including during cardio workouts, **no exceptions.**
- The fitness center will be closed on Sundays November 22 & 29 or until we move into Tier 2 or lower of mitigation.
- The fitness center will use Sign Up Genius reservation system that can be found on the fitness page of our website [www.barringtonparkdistrict.org](http://www.barringtonparkdistrict.org) beginning Thursday, November 19<sup>th</sup> at 10am. Reservations will be available online in one week increments. Reservations must be made the day prior by 5pm. Per Department of Commerce and Economic Opportunity guidelines walk ins WILL NOT be accepted. You may call the fitness desk 847.304.5279 to see about availability for day of reservations. Walk ins WILL NOT be accepted. Instructions on using Sign Up Genius are posted on the website. - All group exercise classes have been cancelled, including Team Training, Jazzercise and Silver Sneakers until Tier 2 or lower of mitigation
- The fitness center will remain open with a capacity of 21 patrons
- The track will remain open with a capacity of 10
- 1:1 personal training may continue with advance notice

#### **Front Desk:**

- The front desk will be open Monday – Friday beginning Friday, November 20 from 8:30am – 6pm until we move to Tier 2 or lower of mitigation
- The front desk will be open 8am – noon on Saturdays, November 21 & 28 until we move to Tier 2 or lower of mitigation
- The front desk will be closed on Sundays, November 22 & 29 until we move to Tier 2 or lower of mitigation

#### **K.E.E.P. 2.0:**

- K.E.E.P. 2.0 will be allowed to continue as scheduled.
- K.E.E.P. will follow the guidelines given by ISBE and IDPH.

#### **Preschool:**

- Preschool will continue to run as scheduled.
- Preschool will follow the guidelines given by IDPH and DCFS.
