**BARRINGTON PARK DISTRICT  
BOARD MEETING MINUTES  
AUGUST 15, 2022**

The Board of Park Commissioners, Barrington Park District, Lake and Cook Counties, Illinois, held a Board meeting at Langendorf Fitness and Recreation Center Clubhouse, 560 Carl Avenue. Commissioner Hovde called the meeting to order at 6:45 p.m.

VII. NEW BUSINESS

**A. Change September 19, 2022 Regular Board Meeting to Monday, September 26, 2022**

**B. Master Plan - District 220 Request at Beese Park**

Director Jennings reviewed exhibits for the Beese Park Path Extension. Gewalt Hamilton Associates, Inc., prepared three options for path extension to provide better accessibility for Prairie Middle School to load and unload students with special needs. Option 1 provides an asphalt ramp while Options 2 and 3 show a concrete ramp but with other differences Discussion followed. It was pointed out that the proposed ramp would not be ADA compliant. Director Jennings was asked to have further discussions with School District 220 representatives and have them clarify their goals for the path extension.

**C. Williams Architects - Frank Parisi**

Frank Parisi of Williams Architects reviewed three design proposals for pickleball and tennis courts. Options 1 - 3 showed the courts located in Citizens Park with an additional Option 1 showing the courts located at Langendorf Park. Director Jennings said she did not want to lose a tennis court and did not favor the option that depicted a loss. Discussion followed. There was agreement that the option locating the courts at Langendorf Park was preferred, but the skatepark would need to be moved to where the tennis platforms were. Mr. Parisi said the process on aquatic design is still developing and hopefully will be presented at the September meeting. Director Jennings said she and staff visited numerous pools this summer to get ideas and there is good dialogue taking place between staff and Williams Architects on the design.

**D. Special Request for Village of Barrington Rental on September 11, 2022**

The Village of Barrington is requesting permission to sell alcohol at the staff appreciation event on September 11, 2022. The event will be catered, and the provider has a license to serve alcohol.

MOTION was made by Commissioner Lundmark, seconded by Commissioner Garry, to allow the Village of Barrington to provide and sell alcohol at their September 11, 2022 event on park district property subject to review by the park district's attorney
